

Arakhamia to Appeal to EU, US Leadership to Consider Personal Sanctions on Ivanishvili, His Assets in West.

avit Arakhamia, Chairman of the Servant of the People faction in Rada has responded to a release of an audio recording of an alleged call between Russian businessman, the founder of Sistemas, Vladimer Evtushenkov, and former Georgian Prime Minister Bidzina Ivanishvili. Arakhamia said that he would appeal to the EU and US leadership to consider imposing personal sanctions on Ivanishvili and his assets in the West.

According to him, Ivanishvili has become Georgia's Yanukovych and he is pursuing a policy toward Ukraine that isn't supported by the Georgian people. Arakhamia states that the country's 'main oligarch' Bidzina Ivanishvili has close ties with the Russian political elite, "which was once again confirmed by the recently spread audio recordings.'

"The nature of the current Georgian government's policy is simply to follow the Kremlin's instructions. This is the reason for their rhetoric of not recognizing Russia's war crimes against Ukraine and helping Russia in bypassing the sanctions," Arakhamia stated.

The audio recording of an alleged call between Ivanishvili and the Russian sanctioned oligarch Yevtushenkov is dated March 10 and March 12 this year and concerns a meeting of Russian businessmen in Tbilisi. In the recording, Ivanishvili allegedly mentions that Prime Minister Irakli Garibashvili had met with Yevtushenkov's envoy. This information has been confirmed by Yevtushenkov himself, who told FormulaTV that Garibashvili had met with his company's vice president, Ali Uzdenov. He explains that the goal of the conversation was 'nothing political' and the sides talked about 'vacation'. As for his relationship

with Ivanishvili, he noted that they only have a friendly relationship and never had business ties with each other.

Irakli Kobakhidze, the head of the ruling Georgian Dream party responded to the release of the audio recording, questioning the authenticity of the recordings and stating that even if it is authentic, 'there is nothing special in it' as "two businessmen were talking about trade relations with each other.'

According to him, the Georgian Government's stated position of keeping the trade relations with the Russian Federation" is not against any law and does not contradict any other principles".

"Ukraine is also involved in trade relations with Russia; therefore, the fact that Georgia maintains the trade relations is neither illegal nor immoral," Kobakhidze stated.

The head of the GD party also responded to Arakhamia's statement calling Ivanishvili a Georgian Yanukovych, saying that "they should search for Georgian Yanukovych in the Ukrainian government". He also stated that Arakhamia is in radical opposition in Georgia, while in Ukraine he is in power, adding that the Georgian society would learn even more about Arakhamia after the end of the war.

gia, Shalva Papuashvili said that the recording, which according to him is fabricated, is a part of a disinformation campaign against Georgia, aiming to 'cause unrest in the country and to involve Georgia in the war'. As he stressed, there is no indication that these records are authentic.

"Overall, the goal of this is to cause unrest in the country, this is a stated goal to change the Government in an undemocratic way and then involve the country in a war," Papuashvili said.

Yesterday. Lelo MP Salome Samadashvili demanded the summoning of Prime Minister Irakli Gharibashvili to the Parliament, according to interpellation rule. As she noted, since Ivanishvili could not be summoned to the Parliament, his 'assistant', Garibashvili, should answer all the questions related to the position of the Government regarding the sanctions regime and spread recording.

The Head of the National L Bank of Georgia (NBG) Koba Gvenetadze attended the annual conference hosted by Columbia University, the main topic of which was 'Inflation and Market Challenges and Response in Emerging Economies'.

During his address, NBG President raised the globally challenging topic of inflation, indicating the need for the central banks' vigilance and monetary authorities' strong reaction to prolonged high inflation.

He said that inflation is rising all over the world, even before the launch of the Ukraine invasion by Russia in February. According to him, supply-demand mismatch and rising commodity (fuel and food) prices have stimulated inflation growth since early 2021.

'Central banks need to be vigilant now, as long-standing high inflation will come at a fairly high cost and the monetary authority will have to respond

more strongly. Some central banks in young markets, including the NBG, have already tightened monetary policy to prevent this, in response to rising inflation expectations at the beginning of the normalization cycle of developed economies."

"However, recent inflation risks are forcing central banks in young markets to further accelerate policy tightening to meet those expectations, which are growing rapidly in the face of prolonged inflation. That is why we tightened the rate of our policy at the last sitting of the Monetary Policy Committee," Gvenetadze clarified.

The NBG increased its refinancing rate from 0.5% to 11% on March 30 due to increased risks of high inflation expectations and inflation being above the target for a prolonged period.

Current Trends in Loans & Deposits in March

The central bank released in formation on current trends in loans and deposits of resident commercial banks as of March 2022. According to them, the volume of loans issued by commercial banks in March 2022 increased by
 67.52 million, or 0.16% compared to the previous month, and amounted to d 43.32 billion as of April 1 of this year.

According to the Central Bank, in the same period, the volume of loans in national currency increased by
^(the) 281.95 million (1.34%) while the volume of loans in foreign currency decreased by
^{(the decision dec} (0.975).

At the end of March 2022. commercial banks issued loans of # 6.58 billion in national currency to resident legal entities, which is 0.24% more than in the previous month, and @ 13.7 bilous month.

According to their report, during March 2022, the volume of lending to the resident household sector increased by 0.8% and amounted to **(** 22.16 billion by April 1 of this year.

The 'larization' ratio of total loans stood at 49.36%, up 0.57 percentage points from March 1, 2022.

The volume of non-bank deposits in the banking sector amounted to @ 37.1 billion as of April 1, 2022, which is 1.41% less than on March 1. According to the report, in March, compared to the previous month, there was a decrease in time deposits by 6.24%, while demand deposits increased by 2.3%. The 'larization' rate of deposits for April 1 this year was 40.6%, a decrease of 0.14 percentage points in the last month.

In March, the weighted average annual market interest rate on time deposits was 6.99%, including 11% on deposits in national currency and 0.81% on
