During his official visit to Brazil, Georgia's Minister of Foreign Affairs, Ilia Darchiashvili, met with Brazil's Minister of Foreign Affairs, Mauro Vieira.

According to information from the Ministry of Foreign Affairs, during the meeting, the ministers welcomed Darchiashvili's visit to Brazil after a long hiatus. They emphasized the special significance of this visit, given the global processes underway and the important regional roles of both countries.

Additionally, as reported by the Ministry of Foreign Affairs, Darchiashvili underscored the particular importance of partnership with Brazil for Georgia, in both bilateral and regional contexts.

"The ministers welcomed the intensive political dialogue between the foreign ministries of the two countries and reviewed the opportunities for cooperation in various sectors. Special attention was paid to the trade and economic direction. It was noted that Georgia is interested in developing ties with Brazil, as the world's leading economy, and fully demonstrating its economic potential. In this regard, the conversation touched on the importance of Georgia as a country carrying out the transit function connecting Europe and Asia, and the positive dynamics of its economic development. The ministers expressed interest in promoting regular contacts between business circles and facilitating the exchange of trade mission visits." the statement reads.

It was also noted in the statement that special attention was paid to granting Georgia the sta-

tus of a candidate country for EU membership. The parties reviewed the security challenges in the European region and the world. Mauro Vieira emphasized Brazil's strong support for Georgia's sovereignty and territorial integrity.

"Georgia's traditionally active cooperation with Latin Ameri-

can and Caribbean countries and Tbilisi's official involvement in various regional formats of South America were noted. Additionally, Georgia's activity in the unification of Portuguesespeaking countries, where Georgia serves as an associate observer, was emphasized.

The high-level cooperation es-

tablished between the two countries in the fields of people-to-people relations and culture was positively evaluated. This cooperation aids in increasing awareness of each other in Georgia and Brazil and in popularizing the cultural identity of these countries. The ministers welcomed the existing visa-free re-

gime between Georgia and Brazil and noted with satisfaction the growing trend of tourists from Brazil to Georgia.

The parties emphasized the special importance of the tourism industry for both countries and expressed their readiness to make efforts for further cooperation in this regard," the statement reads.

Georgia's Prosecutor's Office Seeks Extradition of Former Minister Zurab Adeishvili from Netherlands

The Prosecutor's Office of Georgia has formally requested the Neth erlands to arrest Zurab Adeishvili, former Minister of Justice of Georgia, and to extradite him to Georgia. According to them, the appeal was made on the basis of publicly disseminated information.

"The Prosecutor's Office of Georgia, within the framework of its powers, implements all measures provided for by the law to bring individuals who have committed crimes in Georgia to face justice in Georgian courts, regardless of their location.

In this case as well, based on publicly disseminated information, the prosecutor's office appealed to the competent agencies of the Netherlands to arrest Zurab Adeishvili and extradite him to Georgia," the statement reads.

Adeishvili, adviser to the Prosecutor General of Ukraine, has joined the delegation from Ukraine, led by General Prosecutor Andrey Kostin, at the international conference "Restoring Justice for Ukraine," hosted by the Netherlands. During their visit, they also met with the Minister of Justice of the Netherlands. Notably, Adeishvili, who faces several criminal cases in Georgia, recently visited the Bundestag and the European Parliament. He left Georgia in 2012.

According to the prosecutor's office, Zurab Adeishvili is accused of torture of prisoners, the murder of Buta Robakidze, assaulting Koba Davitashvili, and involvement in other criminal cases.

ESU Public Speaking Competition 2024

The main goal of the English Speaking Union (ESU) is promoting friendship and understanding through the English language.

ESU is more than 100 years old. Over the last century, the English-Speaking Union has become a unique global educational charity that brings together people of different languages and cultures. ESU is involved in many cultural and educational programmes. The most popular is the International Public Speaking Competition. It is the largest public speaking competition in the world. It involves 1 000,000 young speakers, between 16-20, from over 50 countries. Through the international final in London, students from around the world have the opportunity to meet, form friendships and understanding that will last a lifetime.

Georgia joined the English Speaking Union in 1998. Since then, for 26 years running, ESU-Georgia has been organizing ESU Public Speaking Competition.

ESU-Georgia is sponsored by the Bank of Georgia.

In her speech Marina Tsitsishvili, the President of ESU-Georgia said:

"We can already boast that we have our own history and statistics:

- 1. First of all, we must say that the popularity of this competition, as well as, the number of speakers taking part in it is growing every year. If at our first Public Speaking Competition, in 1998, we had only 10 speakers and two of them went to London, this year there were about one hundred.
- 2. Secondly, we must admit that the level of the speakers' English and their skills in public speaking has improved considerably.
- 3. Our statistics also show that young ladies in Georgia are more active and hard-working than young men. In 25 years of our history we sent to London 38 young speakers to participate in the final, in London. Only 8 of them were boys.

But this year we were surprised to notice that young Georgian males are waking up. If we judge by the number of boys who got to the final this year, this tendency is promising. The level of speakers was so good that it was difficult to choose the best."
